I. Call to Order

WAMU Theatre for 2019. He announced that the Rolling Stones concert was rescheduled to August 14, 2019.

Jim Reid, PSA Consultant, provided a brief summary of the final draft succession plan he created, in consultation with Board and staff, for the PSA. The Board discussed the various options and timeline for staff retirement and hiring new employees. Ms. Romero asked the Board for approval to hire a consultant to help with the job search.

5. PSA FY2020 Operating Budget

Ms. Kawasaki Romero stated that the proposed budget of \$1.256 million is a 4.67% increase from the adopted 2019 fiscal year budget. 100% of the budget is covered by lease payment from First & Goal and interest income. There is a onetime increase in personnel costs due to a planned retirement and potential new hire overlap.
